TEMPORARY RESTRAINING ORDER

on his request for
~~After a hearing and upon notice to Counsel for Defendants, and upon consideration of the parties' written and oral submissions, the Court finds that Plaintiff, Stanley F. Collesano, as a Board Member, Executive Committee Member and Member of the Indiana Association of USA Track & Field, Inc., ("Plaintiff") is entitled to a temporary restraining order against Indiana Association USA Track & Field, Inc. ("INUSATF"). Plaintiff have shown: (a) that he is highly likely to succeed on its Inspection for Corporate Records claim, (b) that continued operation of hosting the USA Track & Field Indoor Masters Championships will cause immediate and irreparable harm that could not be remedied adequately by a later award of damages, (c) that the balance of harms as between the parties favors plaintiff, and (d) that the public interest favors injunctive relief.~~

~~Accordingly, Defendant, Indiana Association of USA Track & Field, Inc. ("INUSATF") is hereby ORDERED.~~

- ~~1. To immediately cease any and all activities associated with hosting USA Track & Field Indoor Masters Championships in any manner.~~

2. ~~To immediately cease use of the any and all bank accounts or funds of INUSATF.~~

This temporary restraining order shall be binding upon INUSATF, its members, officers, agents, servants, employees, and attorneys, and upon those persons in active concert or participation with them who receive actual notice of the order by personal service or otherwise. This temporary restraining order shall take effect at the time of its issuance and shall continue in force and effect, unless otherwise modified by the court. .

The court will hold a hearing on plaintiff's motion for a preliminary injunction on the

9th day of March, 2012 at 10:30 A.M./P.M.
